

The West of Berkshire Safeguarding Adults Board Briefing Note

Welcome to the West of Berkshire Safeguarding Adults Board briefing. The Board meets four times a year and discusses how agencies should work together to keep adults at risk of abuse or neglect safe in Reading, West Berkshire and Wokingham.

Each Board focuses on a key priority set out in the Boards Strategy. In September 2019, the focus was on Targeted Exploitation.

The Board heard presentations from:

Thames Valley Police, on their response to Financial Exploitation of vulnerable people. Financial Fraud and online crime is believed to cost the UK Economy £2 Million each day and the allegations are increasing. Vulnerable People are at high risk of being targeted and once someone is a victim of fraud, they are more likely to be targeted again. Reading Borough Council, West Berkshire District Council and Wokingham Borough Council, provided a presentation on their response to the lessons learnt from Daniel, a Safeguarding Adults Review (SAR) regarding Financial Abuse, endorsed by the Board in June 2020.

Safeguarding Strategy 2018-2021

The Board has a 3-year strategy setting out 4 key priorities. An annual Business Plan contains actions to support the delivery of these priorities. The priorities were reviewed and revised in July 2019:

Priority 1: We will provide the partnership with the tools and framework to work effectively with people who Self-Neglect

Priority 2: The Board will work collaboratively with the Berkshire West Safeguarding Children Partnership, Community Safety Partnerships and Health and Wellbeing Boards to provide the workforce with the frameworks and tools to work with Vulnerable Adults who are at risk of Domestic Abuse.

Priority 3: We will understand the main risks to our local population in regards to Targeted Exploitation and agree how best to equip the partnership to Safeguard vulnerable people against these risks.

Priority 4: The Board will understand from key stakeholders why there has been an increase in organisational safeguarding and seek assurance from commissioners that there are adequate preventative measures in place, consistent across the partnership where practical.

The Board accepts that priorities may change as a result of national and local learning.

The purpose of these Policies and Procedures is to support staff to respond appropriately to all concerns of abuse or neglect they may encounter, providing a consistent response across Berkshire.

The Policies and Procedures are regularly reviewed and updated. Recent updates/additions include:

- Berkshire Safeguarding Adults Boards' Information Sharing Protocol
- Pressure Ulcer Pathway
- Allegation Management Framework/Person in a Position of Trust (PiPoT)
- Thames Valley Police Modern Slavery Pathway

Safeguarding Adult Reviews (SARS)

The Board has a legal duty to carry out a Safeguarding Adults Review when there is reasonable cause for concern about how agencies worked together to safeguard an adult who has died, and abuse or neglect is suspected to be a factor in their death; or when an adult has not died but suffered serious abuse or neglect. The aim is for all agencies to learn lessons about the way they safeguard adults at risk and prevent such tragedies happening in the future. The West of Berkshire Safeguarding Adults Board has a Safeguarding Adults Review Panel that oversees this work.

The Board has published four SARS Recently: Aubrey, Paul, Gemma and Daniel, copies of these SARS can be found on our website, along with 2-page practice notes for each SAR to highlight learning for practitioners. <http://www.sabberkshirewest.co.uk/practitioners/safeguarding-adults-reviews/>

For a SAR to be considered by the SAR Panel a notification needs to be made, notifications can be accepted from anyone including members of the public. Further information on submitting SAR notifications can be found on our website.
