

West of Berkshire Safeguarding Adults Board

Briefing no. 12 – July 2023

Welcome to the second West of Berkshire Safeguarding Adults Partnership Board briefing of 2023 and we apologise for not providing an updated in the Spring. Our partnership covers Reading, West Berkshire and Wokingham has a large workplan with several themes to help better support and protect vulnerable members of the community. This is overseen by a management board which meets four times a year.

The management Board last met in June 2023 and the following was addressed:

- Endorsed a Safeguarding Adult Review (SAR) in relation to Sandra.
- Was provided with an update from the <u>Buckinghamshire</u>, <u>Oxfordshire and Berkshire West Integrated</u>
 <u>Care System</u>, our statutory partner and we considered how we can work more effectively together.
- Heard from the Department of Work and Pensions (DWP) and how their new Advanced Customer support team could support vulnerable people in our area.
- Agreed to the recommendation in a report from our Learning and Development Subgroup not to relaunch the safeguarding train the trainer programme.
- Discussed progress on our priorities and agreed to review our risk and mitigation log.
- <u>The Advocacy People</u> delivered a presentation to the Board on the provision of advocacy services across the West of Berkshire.
- Considered results and next steps from the recent Mental Capacity Act Survey undertaken by the Board.
- Discussed the recently published report from Healthwatch West Berkshire on <u>Asylum seeker</u> experiences of living in West Berkshire.

The next Board meeting is scheduled for September 2023.

Mental Capacity Act April 2023 Survey

In April 2023 in response to our current priority to: Embed a good understanding of the Mental Capacity Act within the practice of our partners. We ran a Mental Capacity Act survey with the aim being for the board to better understand the current support available and the challenges within the partnerships for those supporting vulnerable adults in identifying and managing and supporting people with issues around mental capacity.

There was an amazing 199 responses to this survey and the results were considered by the Board in June 2023, this link provides a copy of the presentation.

Key learning from the survey was that there is a lack of confidence in practice in the:

- Assessment of executive function when assessing capacity
- Understanding the criteria for referring to advocacy services
- Assessing capacity when the individual has or may have fluctuating capacity.

The key word when responding to the following question: What would help the wider safeguarding system to improve understanding and practice in relation to mental capacity? Was **training**, particularly scenario-based training.

In follow up to this survey the Learning and Development Subgroup will consider the partnerships training offer for mental capacity and provide recommendations to the Board.

Sandra Learning from a SAR

Sandra died in hospital from a sepsis infection acquired from an injury received in her home aged 65. Sandra had a number of long-term health issues and there was a pattern of her not attending or arranging appointments and then being discharged from services without the intended support being provided.

Concerns were raised 9 years previously that her son had moved into her flat after being evicted from his own accommodation. There were concerns about him physically assaulting Sandra and hoarding. Shortly after these concerns were raised, Sandra was evicted from the property due to its condition and was supported by the local authority in being rehoused.

Over the years further safeguarding concerns were raised about Sandra, all with similar themes relating to the risk of abuse from her son and the condition of her home.

Key Learning Points from this review were:

 The Assessment of Safeguarding Referrals and Social Care Prevention Pathways

Improvement is required in the way that referrals and contacts are initially assessed and allocated for further social work. New prevention pathways are required to ensure that social work teams are structured and resourced to manage cases of differing complexity.

 The Quality-of-Care Act Assessments and Management of Risk

Social workers and managers need further guidance in how to prepare person centred Care Act assessments and safeguarding plans.

- Multi-Agency Information Sharing and Planning
 There is a need to promote the current multi-agency
 arrangements to share information and develop joint
 safeguarding plans. This should include improving the
 understanding of when a referral would still be
 appropriate in the absence of consent.
- Developing Professional Curiosity

 Agencies have identified how a greater level of professional curiosity by their staff would have helped to better identify vulnerability and improve the submission of safeguarding referrals.

The Board have agreed for a task and finish group to be set up to considered and implement actions on the recommendations for this SAR.

DWP Presentation June 2023

The Department for Work and Pensions (DWP) have introduced Advanced Customer Support Team, whose role is to offer more support vulnerable individuals which will sometimes overlap with safeguarding interventions. In June 2023 the DWP delivered a presentation to the Board detailing the function of this new team.

The <u>safeguarding strategy 2021-24</u> outlines what the Board aims to achieve in the next three years. The Board identifies strategic priorities that shapes its work. These are reviewed each year, most recently in March 2023, and are revised to reflect findings from performance information and case reviews.

Priority 1: To seek assurance that quality of health and social care services delivered in the West of Berkshire or those commissioned out of area for West Berkshire residents is monitored effectively and there is a proportionate response to concerns.

Priority 2: Embedding a good understanding of Mental Capacity Act within the practice of our statutory partners.

Priority 3: Serious Violence and Exploitation, understanding the gaps from an adult safeguarding perspective.

Priority 4: Review and relaunch of the SAB Quality Assurance Framework
